



FREE THROW ELIGIBILITY

- ACT comp. 16 – 19
- First-time Freshman status
- Must not have attended a college or university following high school graduation
- Dual enrollment courses taken while in high school before graduation are acceptable
- Submit online application for admission and all required freshman documents
- Submit Free Throw application

FREE THROW BENEFITS

- 12 hours of college credit tuition-free (pending graduation from WCU)
- Opportunity to begin courses at WCU without achieving an ACT score of 20 or higher
- Opportunity to qualify for a scholarship at WCU

FREE THROW REQUIREMENTS

- Must enroll in 12 hours of college courses
- Must be advised by the Free Throw designated advisor in the Office of Student Assistance
- Course placement is determined based upon ACT subscores and course availability
- Must achieve a GPA of 2.5 or higher on the 12 hours of Free Throw courses

AFTER FREE THROW

- Apply for admission to WCU as a transfer student for the second term of attendance
- Students who achieve a GPA of 2.5 or higher on the 12 hours of Free Throw courses will be accepted as an undergraduate student
- Advisement for future courses will be completed by an advisor in the area of academic study
- Students may apply for a scholarship based upon the earned GPA in the 12 hours of Free Throw courses
- After the completion of 30 hours at WCU, students may be eligible to take up to 12 hours at another college or university to transfer back to WCU. To qualify, students must request a Letter of Good Standing from the Office of Academic Affairs

TERMS AND CONDITIONS

- A maximum of 12 Free Throw credits are available
- **Students must achieve a GPA of 2.5 or higher on the 12 hours of Free Throw courses**
- Student must continue and finish their degree at WCU
- **Students who do not achieve a GPA of 2.5 or higher on the 12 hours of courses will be denied admission for subsequent terms to WCU and must pay tuition for the 12 hours of Free Throw courses**
- Students who transfer to complete a degree at another college or university must pay tuition for the 12 hours of Free Throw courses at the current rate of tuition at the time of transfer
